Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

The District maintains a School Site Council (SSC) and District English Language Advisory Committee (DELAC). During the 2020-21 school year, due to the COVID-19 pandemic, all of our communications have been through either phone calls or Zoom meetings. One of the purposes of the SSC and DELAC is to engage parents in the LCAP review and planning process and to get their input into the District's programs and services for students. All parents were sent a survey to elicit their input on this plan regarding the actions and services the District can provide to students to help mitigate learning loss and to provide them with the opportunity to voice their priorities for their students. All school staff members were also notified of the Expanded Learning Opportunities Grant Plan and asked to solicit feedback and input on what actions could be taken by the District to help mitigate the learning loss that has occurred over the past year due to the pandemic. After discussions with stakeholder groups, the following instruction and support strategies were determined as a need for students' academic and social emotional well-being.

- The District will provide four weeks of summer school to increase the amount of instructional time or services provided to students based on their learning needs.
- Continue to provide services and programs that support students' social emotional health and well-being.
- Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including: Tutoring or small group learning supports provided by certificated or classified staff; Learning recovery materials designed to accelerate student academic proficiency or English language proficiency, or both; Educator training for both certificated and classified staff.
- Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

A description of how students will be identified and the needs of students will be assessed.

Students will be identified throughout the 2020-2021 school year through classroom assessments, benchmark assessments, teacher observation, and end of the year assessments. Students identified as being below grade level proficiency in English Language Arts and/or Mathematics will be prioritized for receiving supplemental instruction and support. School attendance and input from teachers, paraprofessionals, and Principal will be used to identify students needing additional social/emotional support. Students will be assessed with District formative assessments to monitor their progress. This process will continue during the 2021-2022 school year.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

For academic and social/emotional support, families of students identified as requiring additional services will be contacted by the District by written communication, phone, electronic communication or in-person in their primary language. For summer meals, a schedule of meal deliveries will be sent to families using the aforementioned methods.

A description of the LEA's plan to provide supplemental instruction and support.

The District will provide a summer school/tutoring program each summer during the grant period. Credentialed teachers and paraprofessionals will provide instruction/intervention to small groups of students (ten or fewer). The primary focus of the summer instruction will be English Language Arts and Mathematics but may also include instruction in additional core content areas. The District will provide an afterschool tutoring program during the regular 2021-2022 school year focusing on ELA and mathematics. English learners, foster youth, homeless, students at risk of neglect or abuse, disengaged students, students below grade level, and students with disabilities will be prioritized for these supplemental services. Providing these students with academic and enrichment activities as well as health and social support services during times when they would not normally be in school is an increase in services and an extension of instructional learning time. The District will provide additional professional development opportunities for teaching and support staff, especially in the areas of supporting students' social-emotional needs.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

The District will coordinate ELO funds with other funding sources to maximize the programs and services that students receive. Employees that provide direct services to students funded through the ELO grant may be funded with alternate funding sources including, but not limited to ESSER after the ELO grant expires at the end of the 2021-2022 school year. ESSER funds will be used to reduce class sizes to provide more opportunities for small group and one-on-one instruction. The after school tutoring and summer

school sessions funded with the ELO grant along with the smaller class sizes funded through ESSER work together to support students to mitigate learning loss that has occurred as a result of the COVID-19 pandemic related school closures.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students’ college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students’ social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
