During the 2020-2021 school year, Di Giorgio Elementary School District parents, students, special education administrator, district/site administration, local bargaining units, and stakeholders were given opportunities to attend discussions/meetings with school personnel in person as well as via web conferencing to provide feedback/input/suggestions and to respond to surveys relating to the Expanded Learning Opportunities Grant Plan (ELOGP) and the Local Control Accountability Plan (LCAP). At the beginning of the 2021-2022 school year, feedback was solicited from the DESD stakeholders, including parents, students, local bargaining units, special education administrator, and district/site administration for the ESSER III Expenditure Plan via electronic survey. In conjunction with feedback and input from the prior school year and the recent feedback from stakeholders DESD developed the

ESSER III Expenditure Plan to address the most pressing needs as determined by stakeholder feedback. Stakeholder groups that contributed to the development of this plan include students, parents/guardians, teachers, support staff, parents/guardians of students with disabilities, parents/guardians of English Learners. Prior to the October 20, 2021, DESD Governing Board meeting, the ESSER III plan will be posted on the DESD website.

The DiGiorgio School District evaluated its stakeholder engagement opportunities and determined that Civil Rights Groups, Tribes, and Advocates are neither present nor served by the LEA.

A description of how the development of the plan was influenced by community input.

The feedback received during the 2020-2021 school year in relation to the LCAP and ELOGP was incorporated into the development of this plan as it remains consistent with more recent feedback relating to the ESSER III Expenditure Plan. To obtain input on the optimal use of ESSER III funds a survey was developed and made available to students, staff, parents, and the community. The main areas of focus as determined by various segments of the school community are listed below. A list provided by the California Department of Education of allowable uses for ESSER III funds was added to the survey and Respondents were asked to identify three areas they deemed most important and valuable uses of the funds. Respondents identified items 1, 2, 3, and 5 as the most pressing needs, and have been included in the plan. This plan was solely influenced on community input.

1. Improvements to facilities to improve environmental health and safety, such as HVAC units to improve indoor air quality, roofing projects to improve indoor air quality, and painting projects.
2. Programs and activities to address learning loss.
3. Student social/emotional/mental well-being.
4. Continued emphasis on technology.
5. Additional support for special populations, such as students with disabilities, English Learners, economically disadvantaged students, and other

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

- Addressing learning loss among students, including underserved students, by:
 - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
 - Implementing evidence-based activities to meet the comprehensive needs of students,
 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;
